CLAIM OF ATHLETES

Through this letter, the following athletes want to show our firmest and absolute rejection of the latest actions of CELAD. The latest news has done nothing more than exceed certain limits and provoke certain feelings of distrust, uncertainty and indignation towards our leaders in matters of struggle against anti-doping.

As professional athletes, we recognize the difficulty of decisively ending doping. As a "scourge" that spreads and corrupts sport, all sectors must, and are obliged, to reject any practice that represents a violation of the anti-doping policy defined by WADA. Therefore, we firmly believe that our leaders have to act with rectitude and transparency, a situation that, as we have learned from the media, has not been the case.

Nowadays, all Spanish athletes can be victims of the distrust of our society and of our colleagues from other countries due to the latest news that has emerged. But the worst of all is that we may find ourselves at the top of the iceberg.

This mistrust can affect us, not only the discredit on the part of the others¹ but also its possible consequences in terms of sponsorship, awards and a long etcetera.

When an athlete uses doping, the first person affected is himself due to the damage to health that occurs and, the second, are his teammates/rivals, technical team, family and friends around him.

That, today, there are rumors of "so 6 cases filed in a drawer", is not permissible in a country like Spain. We here present demand the initiation of the different disciplinary proceedings, their sanction and their disclosure in Sanction.

We insist: until we proceed correctly and appropriately, all of us are suspected of being one of the cases in that box."

It should be noted that our involvement in the fight against anti-doping goes beyond this mere writing. We must not forget that Organic Law 11/2021 on the fight against doping in sports includes the following in its Chapter 11, article 6: The Agency will have a body for participation, coordination and monitoring in which athletes will be represented... Specifically, we are referring to the Anti-Doping Coordination Commission, since Royal Decree 908/2022, which includes the modification of the Statutes of the State Agency, is reflected in its explanatory statement and explanation of the creation

of the Anti-Doping Coordination Commission: which is configured as the body for participation, coordination and monitoring of the CELAD in which the athletes as well as the competent bodies and agencies of the autonomous communities in the fight against doping in e/sport.

We do not have any news that there is any athlete in any CELAD participation body. We urge sports authorities to respect the same law due to the relevance of having professional athletes in the highest body against the fight against doping. We have always been delegated to the background when we are the main actors and those who are suffering the most from the consequences of this crisis without precedents in the history of the fight against doping in Spain.

Spain, and Spanish sport as one of the sectors that form the 'Brand Spain', must be a country that defends and promotes clean sport. The work of our authorities is to protect clean and fair sport, a work that does not it has been realized correctly.

For this reason, we demand the names of the athletes who come here collected from the Government of Spain, the Ministry of Education, Vocational Training and Sports and the

Higher Sports Council necessary and urgent measures that will once again give confidence to athletes and our society that doping is a matter that must be combated and eradicated by all sectors.
